ARTICLES OF ORGANIZATION OF STOCK CONSTRUCTION, LLC, a Florida Limited Liability Company

The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company (the "Company") shall be STOCK CONSTRUCTION, LLC, a Florida limited liability company.

ARTICLE II PRINCIPAL PLACE OF BUSINESS
