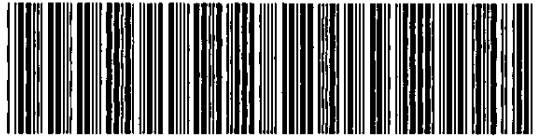



1. Article V is amended to read as follows:



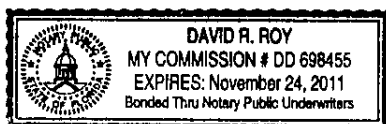


