**ARTICLES OF ORGANIZATION
OF
SMITH HILL, PLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, the following are adopted as the Articles of Organization of the limited liability company organized hereby:

FIRST: The name of the limited liability company is:




