ARTICLES OF ORGANIZATION OF DCS MARKETING, L.L.C.

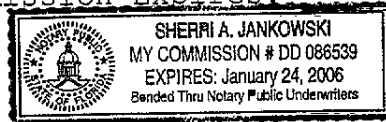
