### ARTICLES OF ORGANIZATION OF COPELAND PARTNERS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

#### ARTICLE I - NAME

The name of the limited liability company shall be Copeland Partners, LLC.
