
ARTICLE V



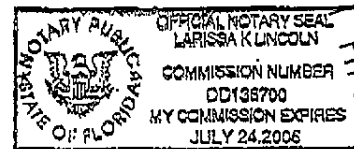
