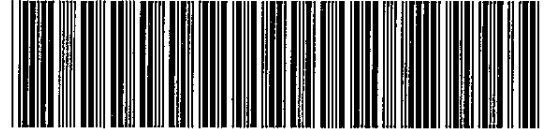

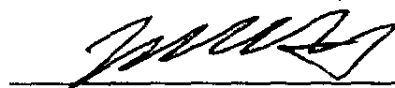
ARTICLE I is deleted in its entirety and the following is substituted in its place:
