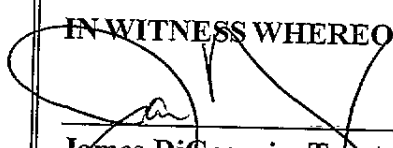

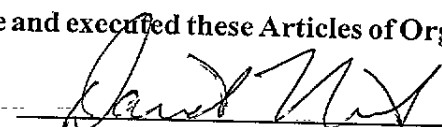
4. **Management.** The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager - managed company.

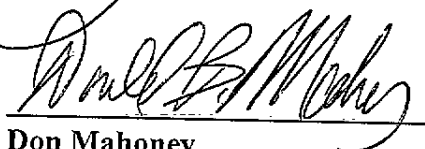
