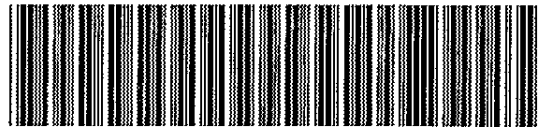

ARTICLE OF AMENDMENT
TO
ARTICLES OF ORGANIZATION OF

“CORAL GROUP LLC, a Florida Limited Liability Company

- First: The date of filing of the articles of organization was October 22, 2002
- Second: The following amendment to the articles of organization were adopted by the limited liability company:

Article III, Section A.

On February 3rd 2003, ARNALDO JORGE FURMANSKI did sell to CANTOR FABIANA MARCELA of Argentina, a Sole Proprietor 51% of all outstanding units, plus 9% of all outstanding units to ARIEL EDUARDO FURMANSKI.

Therefore owners of the 1000 outstanding units will now be owned as follows:

PURCHASE AGREEMENT

This AGREEMENT, is made this 1st day of February 2003 by and among Arnaldo Jorge Furmanski (collectively the sole "Member" & its sole unitholder) of Coral Group LLC, a Florida Limited Liability Company and CANTOR FABIANA MARCELA of Argentina, a Sole Proprietor Company plus Ariel Eduardo Furmanski, an individual.

Whereas, all parties have agreed on a fair and reasonable monetary value of \$36,000.00 for all outstanding units(1000 units) of Coral Group LLC.

After all parties agreeing on such sum, Arnaldo Jorge Furmanski has agreed to sell 51% (of all outstanding units) of Coral Group LLC to CANTOR FABIANA MARCELA of Argentina, a Sole Proprietor Company for an amount of \$18,360.00(Eighteen thousand, three hundred and sixty dollars with no cents). Such sum is to paid to Arnaldo Jorge Furmanski by certified funds at time of signing this document.

Furthermore, Arnaldo Jorge Furmanski agrees to sell 9% of his remaining units of Coral Group LLC to Ariel Eduardo Furmanski for an amount of \$3,240.00(Three thousand, two hundred forty dollars and no cents). Such sum is also to be paid to Arnaldo Jorge Furmanski by certified funds at time of signing this document.

It hereby agreed that Arnaldo Jorge Furmanski will retain 40% of Coral Group LLC, with CANTOR FABIANA MARCELA of Argentina, a Sole Proprietor owning 51% of the units and Arnaldo Eduardo Furmanki owning 9%

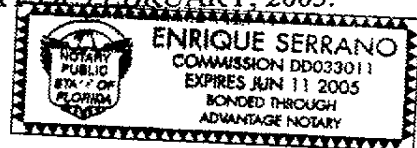
