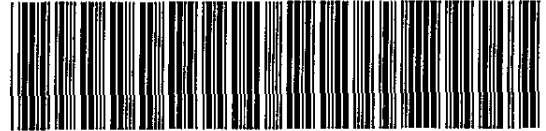



The mailing address, street address, and principal office of the Limited Liability Company is:



**ARTICLE FOUR**


The members may admit additional members to this Limited Liability Company only with the written consent of all existing members.
