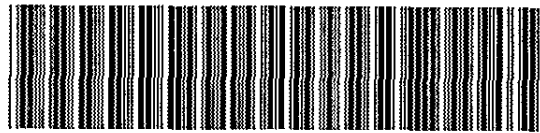


**ARTICLE OF ORGANIZATION**




