The members, at a meeting of the members held not less than annually, shall designate the manager(s), who may also be members, and the positions that such manager(s) shall hold. The initial manager(s), who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:

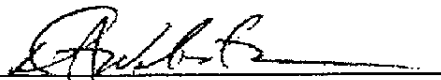

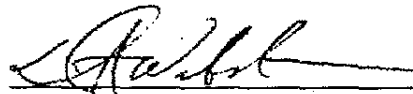

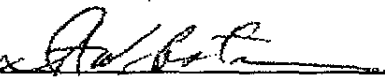
