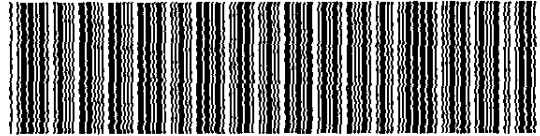

member-managed company.

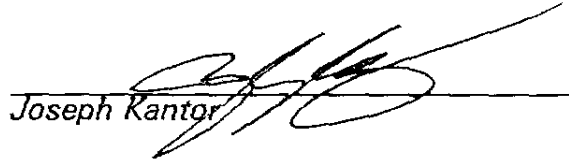
ARTICLE V

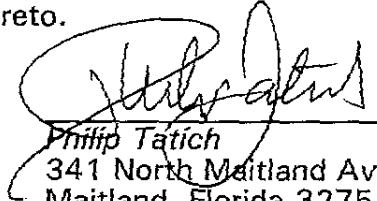
