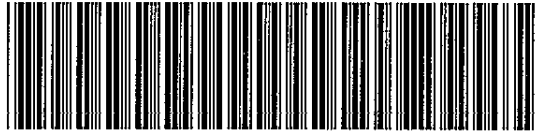


**ARTICLE VI.
