ARTICLES OF ORGANIZATION OF
REAL ESTATE DEVELOPMENT I, LLC

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

SECOND: REAL ESTATE DEVELOPMENT I, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, REAL ESTATE DEVELOPMENT I, LLC, is formed are:




