The Limited Liability Company is to be managed by one or more managers and is therefore, a manager – managed company.

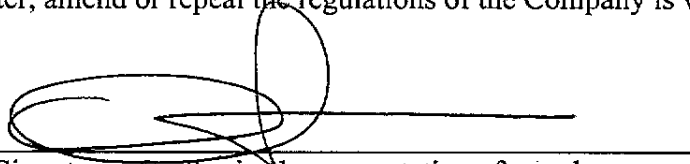
## **ARTICLE VI – Admission of New Members**

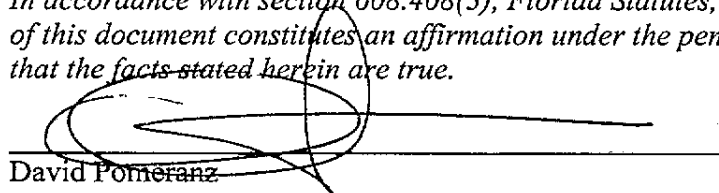
## ARTICLE VII – Adopt resolutions

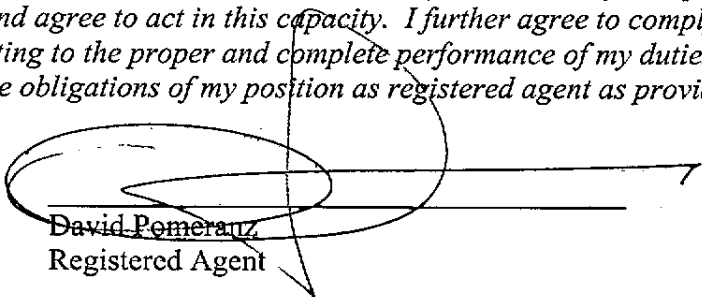
