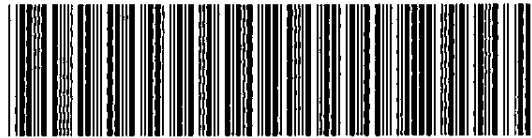

**FIRST:** The date of filing of the Articles of Organization of the above the limited liability company was November 22, 2002.


**SECOND:** The following amendments to the Articles of Organization were adopted by the limited liability company:

**Article VIII** entitled "Compliance with HUD Requirements" is hereby amended by deleting Subsection (iv) of Section (c) thereof and substituting the following Subsection (iv) in its place and stead:

"(iv) Any amendment that would authorize any Member, Manager or party other than the designated Manager named in the Operating Agreement of the Company, or any pre-approved successor Manager, to bind the Company for all matters concerning the Project which require HUD's consent or approval."

Said Section (c) of **Article VIII** is hereby further amended by adding the following Subsection (vi) thereto:

(vi) Any change in a guarantor of any obligation to HUD.
