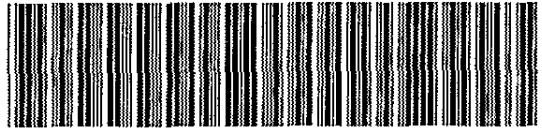

ARTICLES OF ORGANIZATION
OF
1428 E. SEMORAN, LLC

ARTICLE I



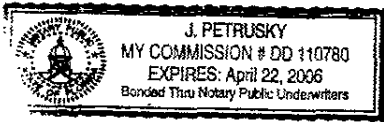
