The mailing address and street address of the principal office of the Limited Liability Company is 2911 N.E. Pine Island Road, Cape Coral, Florida 33909-6513.



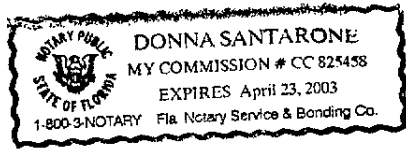


