

TO THE

FIRST AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

INSCOPE IP HOLDINGS, LLC

In accordance with Section 608.411, F.S., the undersigned does hereby certify the following:

First, the current name of this limited liability company is InScope IP Holdings, LLC (the "Company").

Second, the date of filing of this Company's original articles of organization was December 13, 2002.
