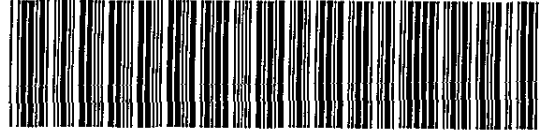

The undersigned acting as organizer of 46th Street Holdings, LLC, under the Florida Limited Liability Company Act, adopts the following Articles of Organization for said limited liability company.

ARTICLE I  
NAME

The name of the limited liability company shall be 46th Street Holdings, LLC, (the "LLC").

ARTICLE II  
DURATION

(a) Members of the LLC shall be entitled to vote on matters relating to the LLC as set forth in the Operating Agreement of the LLC.

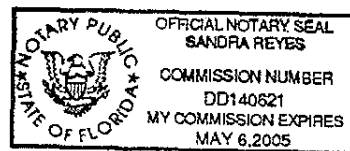
