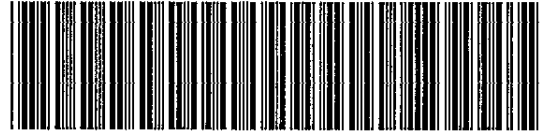

This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as amended from time to time.

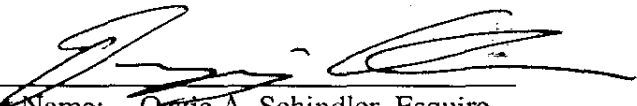

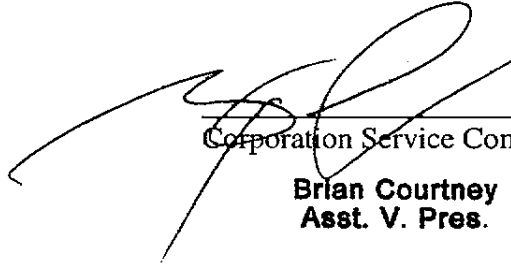
