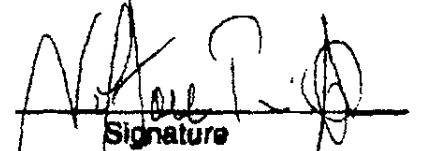

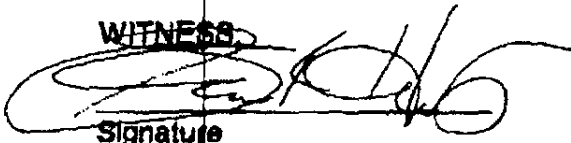

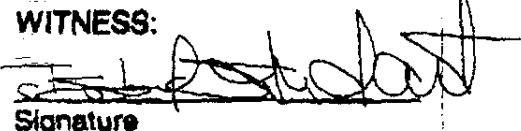
### LIMITED POWER OF ATTORNEY
