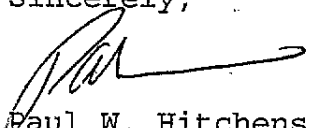

COIN-TEL INTERNATIONAL, INC.

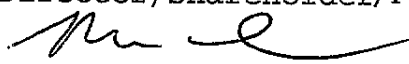
PURSUANT to Florida Statutes Section 607.177(2) (9) and

of the Corporation.

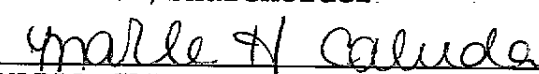

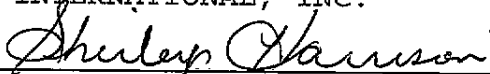
