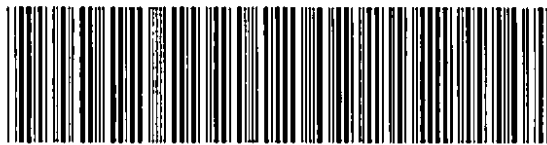

**ARTICLE IV - DURATION**


The period of duration of the Company shall be perpetual.


