#### ARTICLES OF ORGANIZATION

OF

#### GEEVES PROPERTY GROUP, LLC



The undersigned, being Members who desire to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, do hereby adopt the following Articles of Organization and certify:

#### ARTICLE I: NAME

The name of the limited liability company is Geeves Property Group, LLC (the "Limited Liability Company").

#### ARTICLE II: ADDRESSES

The mailing address of the Limited Liability Company is Post Office Box 7831, St. Petersburg, Florida, 33734-7831. The street address of the principal office of the Limited Liability Company is 259 Third Street North, St. Petersburg, Florida, 33701.

#### ARTICLE III: DURATION
