**ARTICLES OF ORGANIZATION OF
CHRISTOPHER R. JOHNSON, PLLC**

The undersigned, CHRISTOPHER R. JOHNSON, a natural person competent to contract, licensed to render services as an attorney at law under the laws of the State of Florida, and sole member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 621, Florida Statutes.

ARTICLE I

The name of the limited liability company is:

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The foregoing paragraphs shall be construed as enumerating both objectives and purposes of the professional limited liability company, and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the professional limited liability company otherwise permitted by law.

ARTICLE IV - TERM OF EXISTENCE

The limited liability company shall have a perpetual existence.

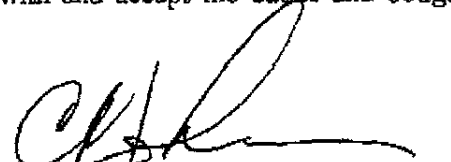
