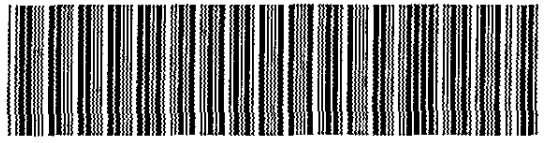

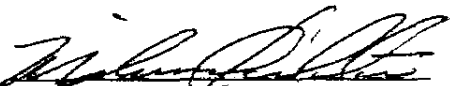

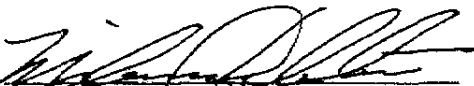

PLAN OF MERGER

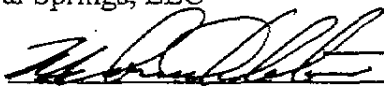
ACCF, Inc. and A1 Body Repair Centers of Coral Springs, LLC, execute this plan of merger and agree as follows:
