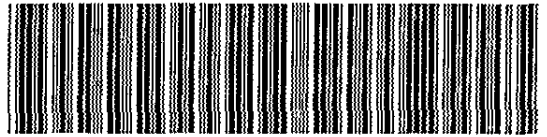

**ARTICLE IV - MANAGEMENT**


The Company is to be managed by a manager or managers and is, therefore, a manger-managed company.
