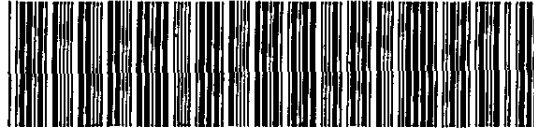

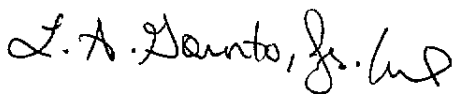

Pursuant to the provisions of section 608.411, Florida Statutes, the undersigned limited liability company adopts the following articles of amendment to its articles of organization:

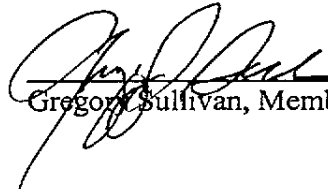
- FIRST: The date of filing of the articles of organization was March 20, 2003.

- THIRD: The date of the amendment's adoption is June 18, 2004.

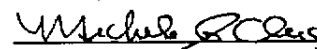
