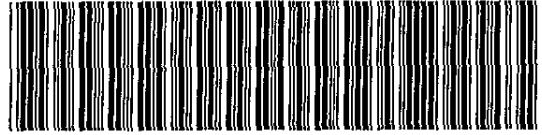





MANAGEMENT**


The Company shall be managed exclusively by its members, and therefore is a member-managed company. The names of the members are:

POWERS**


