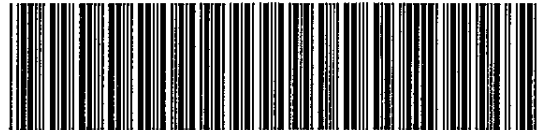

Section 1: PERCENTAGE INTERESTS TO GENERATE CAPITAL: In order for WISCO VENTURES, LLC not to require additional contributions from the Members and Manager Members and after third-party financing has been exhausted, each of the three (3) Manager Members (MGRMS), WISCO ENTERPRISES, LLP, JULIO L. JANE, and INVERSIONES MCQ, S.A., shall be each obligated to return up to 5 of their percentages each (15 total) on an equal basis to WISCO VENTURES, LLC for the purpose of selling them to generate capital as needed and determined by the Manager Members as a Major Decision pursuant to Section 6.2. The value of these percentage interests shall be determined by Wisco Enterprises, LLP, Julio L. Jane and Inversiones McQ, S.A., based first on an certified appraised value, and if not adequate, then based on its marketable value and shall require the approval of all of the the Manager Members or Members.
