Pursuant to the provisions of Section 608.411 of the Florida Statutes, Ayodeji Otegbeye, MD, PL (the "Limited Liability Company") hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the Limited Liability Company is Ayodeji Otegbeye, MD, PL.
2. The original Articles of Organization for the Limited Liability Company were filed on April 21, 2003, and assigned Document Number L03000014106.
3. The original Articles of Organization for the Limited Liability Company shall be amended and restated to read as follows:

FIRST: The name of the Limited Liability Company is Glade Holdings, LLC.

SECOND: The period of duration for the Limited Liability Company shall be perpetual.

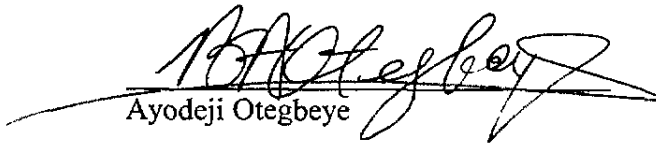

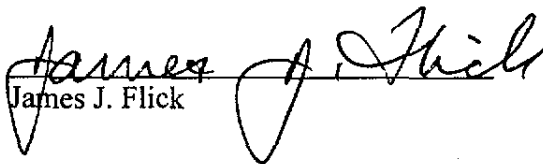
