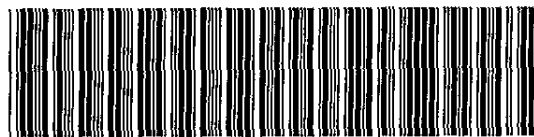

A PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, who is a duly physician in the State of Florida and desiring to form a professional limited liability company in accordance with the Florida Limited Liability Company Act and the Florida Professional Service Corporation and Limited Liability Company Act, does hereby adopt the following Articles of Organization for the Limited Liability Company:

SECOND: The period of duration for the Limited Liability Company shall be perpetual.

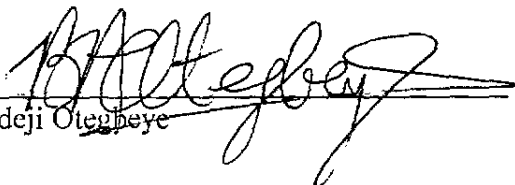
THIRD: The Limited Liability Company is organized for the purpose of engaging in the practice of medicine and to take all actions that are necessary or proper in connection with such services.

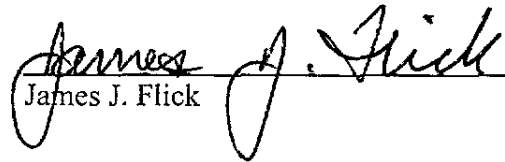
