ARTICLES OF ORGANIZATION OF MICJOSH, LLC

The undersigned, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company act, hereby establishes the following:

ARTICLE I - NAME

ARTICLE X - CONTINUITY

The remaining Members of the Company shall have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued Membership

The return of capital and the distribution of profits shall be determined from the Company's books, as of the effective date of withdrawal, based on the provisions of the regulations, and paid as soon practicable without diminishing the prospects of the Company's venture and subject to the limitations of Florida law.

The business of the Company shall be reserved to and conducted under the exclusive management of its Managing Member according to the provisions of the operating agreement entered into between the Managing Member and Members of the Company. 
