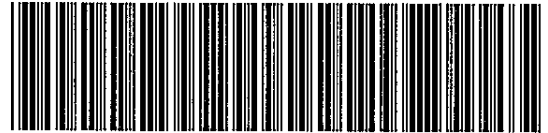

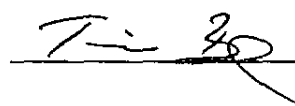
The Company is a manager-managed company.

These Articles of Organization have been executed on May 5, 2003.

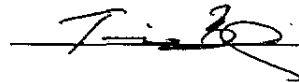
