ARTICLES OF ORGANIZATION

WATERVIEW MANAGEMENT, LLC

A Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE 1: NAME

The name of the Limited Liability Company ("Company") shall be Waterview Management, LLC.

ARTICLE 2: PURPOSE

The Company may engage in any lawful business not prohibited by statute or law.

ARTICLE 3: REGISTERED AGENT

The name and address of the initial Registered Agent is Mark J. Loterstein, Esq., c/o Benson, Mucci & Associates, LLP, One Financial Plaza, Suite 1600, Ft. Lauderdale, FL 33394

ARTICLE 4: PRINCIPAL OFFICE

ARTICLE 5: MANAGEMENT

The Company shall be managed by its Members.

ARTICLE 6: DURATION

The Company's existence shall be perpetual unless terminated by the written agreement of all the members or upon the occurrence of any other event which terminates the continued membership of a member unless the business of the Company is continued by the consent of all of the remaining members.

Any action of the Members may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all Members who would be entitled to vote upon such action at a meeting and filed with the Company as part of its records.

ARTICLE 12: CERTIFICATES

The Company has the authority and shall issue Certificates of Membership to each Member evidencing that Member's interest in the Company. Certificates of Membership shall be signed by an officer of the Company.

ARTICLE 13: TRANSFERABILITY OF MEMBER'S INTEREST

An interest of a Member of the Company may be transferred to such extent and in the manner provided in the Operating Agreement. However, if all of the remaining Members of the Company do not approve of such proposed transfer or assignment by unanimous written consent, the transferee of the interest of such member shall have no right to participate in the management of the business and affairs of the Company or to become a Member. The transferee shall be entitled to receive only the share of profits of other compensation by way of income, and the return of contributions to which the transferor Members otherwise would be entitled.
