ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

Pursuant to Section 608.4232 of the Act, the Company may admit additional members upon the affirmative vote of a majority of those managers of the Company at a duly called meeting of the managers at which a quorum exists or by written consent of a majority of the managers of the Company. ARTICLE VIII. DISSOLUTION OF COMPANY
