

ARTICLES OF ORGANIZATION FOR BAD BOY INVESTMENTS, LLC FLORIDA LIMITED LIABILITY COMPANY

Many 18 PM C: 13 The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I <u>Name</u>

The name of the limited Liability Company is BAD BOY INVESTMENTS, LLC ("Company").

ARTICLE II Address

ARTICLE III Duration |

Each member shall make additional capital contributions to the Company only of unanimous consent of all the members, or as provided in the regulations.

ARTICLE VII Admission of New Members

Except as set forth in the regulations, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII Management

The Company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
