
**ARTICLE VI

AMENDMENT OF ARTICLES OF ORGANIZATION**

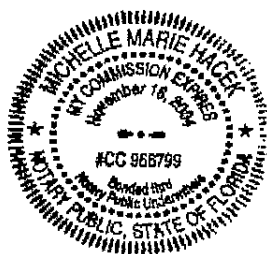




