ARTICLES OF ORGANIZATION

OF

B-I-C, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Liability Company Act, F.S. Chapter 608, hereby make acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be B-I-C, LLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 1316 Poppy Avenue, Pensacola, Florida 32507.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the State of Florida. The company's existence shall terminate not later than 2033 A.D., unless the company is earlier dissolved as provided in these articles of organization.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the initial Registered Agent of the company is Larry L. Cherry, 1316 Poppy Avenue, Pensacola, Florida 32507. The mailing address is the same.

ARTICLE V – CAPITAL CONTRIBUTIONS

Members shall make capital contributions to the company only on the unanimous consent of all the members.

ARTICLE VI – ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous consent of all the members of the company and on such terms and conditions as shall be determined by all of the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the transfer by unanimous written consent.

ARTICLE VII – TERMINATION OF EXISTENCE

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE VIII – MANAGEMENT

The company shall be managed by a manager or managers in accordance with regulations adopted by the members for the management of the business affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. The initial managers of the company are Larry L. Cherry, Duane L. Williams, and Morlan M. Ray, III.

ARTICLE IX – INDEMNIFICATION AND LIABILITY

The company may, as determined by the company's manages, indemnify and advance expenses to a Member, Manager, employee or agent of the company in connection with any proceeding, to the extent permitted by and in accordance with applicable laws and statutes and the regulations of the company.
