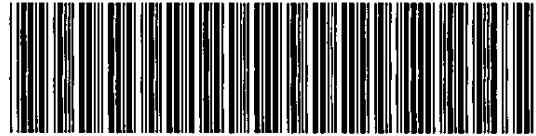

In accordance with the provisions of Florida Statutes Section 608.411, the Members and the Managers of A-SYTORA DISTRIBUTORS, LLC, a Florida Limited Liability company incorporated on June 3, 2003, hereby amend the Articles of Organization of the Company as follows:

1. The name of the company is A-SYTORA Distributors, LLC.
2. The text of the amendment is as follows:

Article I of the existing Articles of Organization of the Company, which relates to the name of the limited liability company, is hereby deleted in its entirety and the following new Article I shall be inserted in lieu thereof:

ARTICLE I

The name of the Limited Liability Company is SYTORA Distributors, LLC.
