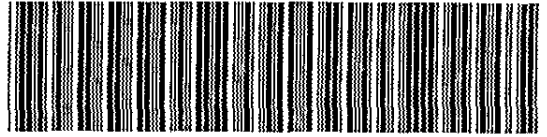

**ARTICLES OF ORGANIZATION**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

**ARTICLE I - NAME**

The name of the Limited Liability Company is "TOMIG INVESTMENTS, LLC".

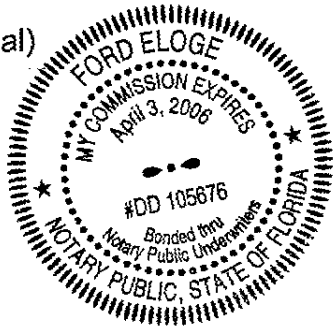
