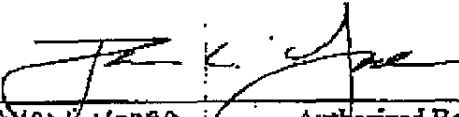
FURTHER, the Articles of Organization are further amended by deleting in its entirety the present Article II - Address and by substituting therefor the following, to-wit:
