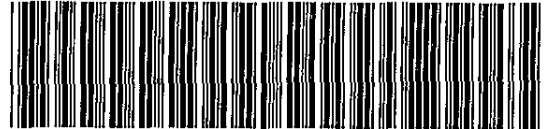

NAME


The name of the limited liability company shall be CAFAMI, LLC, (the "Company").
