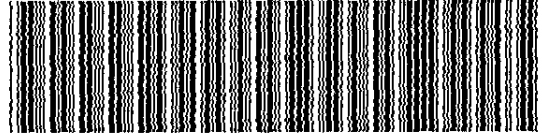

(a Florida Limited Liability Company)**

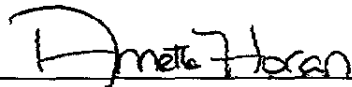
