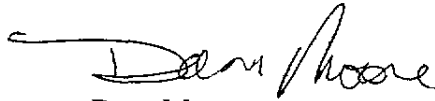

Article I shall be deleted in its entirety and the following Article I shall be inserted in lieu thereof:

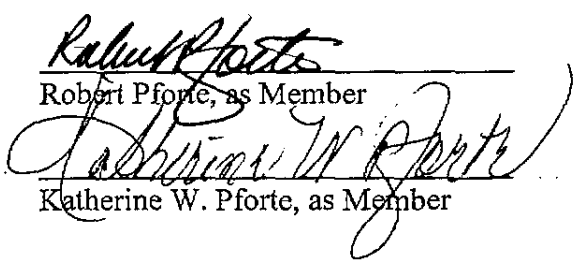
ARTICLE I – NAME

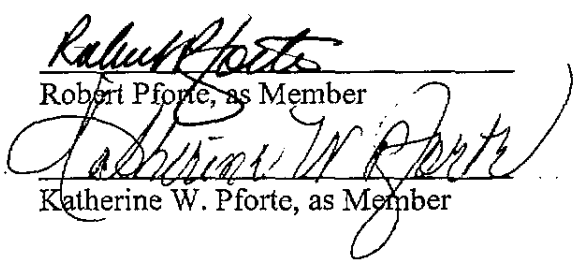
The name of the limited liability company created hereby (hereinafter, “the Company”) is: **RRP HOLDINGS, LLC.**
