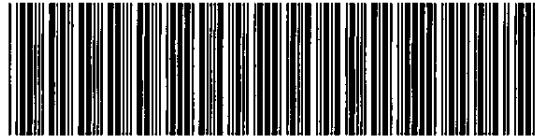

- I. The name of the limited liability company is: MCC/, LLC
- II. The mailing address of MCC/ is PO Box 2235, Tallahassee, FL 32316-2235.
The physical location, and principal place of business, of MCC/ is 1696 Capital Circle, SW, Tallahassee, FL 32310.
- III. A. Lawton Langford is designated as agent of the limited liability company upon whom process against it may be served. The mailing address of the registered agent is PO Box 2235, Tallahassee, FL 32316-2235. The physical address of the registered agent's principal place of business is 1700 Capital Circle, SW, Tallahassee, FL 32310.
- IV. MCC/, LLC is to be managed by one, or more, representatives of its member, Municipal Code Corporation, which representative(s) shall be considered Managing Member(s). The Chairman, President or Executive Vice President of Municipal Code Corporation are the officers authorized to serve as the Managing Member of MCC/, LLC. As of this date the following people serve in the above mentioned positions:

The Managing Member(s) may hire a General Manager to assist with the day to day affairs of MCC/*i*, LLC, and delegate to that person the responsibility, among other duties, to hire and fire employees, sell products, sign contracts for the sale of products, purchase equipment, rent building facilities and other equipment, open operating accounts at financial institutions, enter strategic partnerships, and make other operational decisions. The Managing Member(s) may not delegate to the General Manager the ability to become indebted, make acquisitions, sell or otherwise dispose of a significant portion of the assets of MCC/*i*, LLC. As of this date, Donny W. Barstow has been hired as the General Manager of MCC/*i*, LLC.

The Managing Member(s) may enter into an Operating Agreement governing the rights and responsibilities of members and/or managers, as a group or individually, so long as said Operating Agreement does not create a conflict with, or exceed the scope of, Operating Agreements authorized under Chapter 608 of the Florida Statutes, as amended.

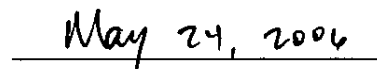

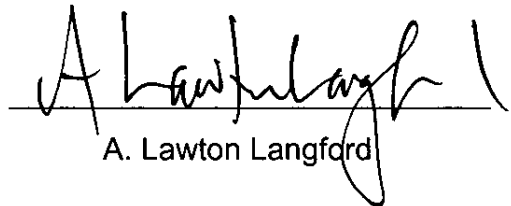

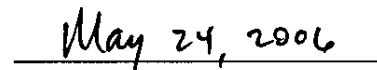
