



ARTICLES OF ORGANIZATION of TRIM FAN, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (The "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. **NAME**.

The name of the Limited Liability Company is **TRIM FAN, LLC** (hereinafter referred to as the "Company").

2. **PERIOD OF DURATION**.

The period of duration of the Company shall be perpetual, unless it is dissolved as provided in the Florida Limited Liability Act or the written Operating Agreement to be executed by all of the Members of the Company.
