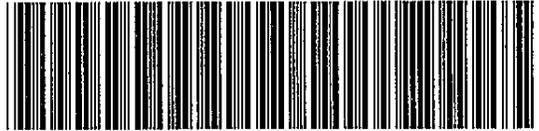

The mailing address and street address of the principal office of the Company is 2361 Bridgette Way, Green Cove Springs, FL 32043.

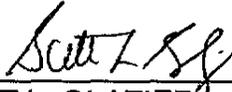
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS
